The above puppy has been examined by a licensed veterinarian and found to be in good health.

This puppy should be examined by your licensed veterinarian within seventy-two (72) hours of receipt. If your veterinarian determines the puppy to be ill, or for any reason this puppy is unacceptable, Buyer may return the puppy for a full refund, provided it is in the same condition as at the time of purchase. If puppy is returned due to illness, a verified letter from your veterinarian is required. This includes death or illness from any health condition deemed present prior to removal from our premises.

That said dog will be given adequate and proper shade and housing and sufficiently fed. This dog shall not be neglected in any manner and in no manner mistreated.

That said dog shall receive adequate and proper veterinary care throughout his/her lifetime and all inoculations maintained to insure preventive health care.

That Buyer guarantees Seller right of first refusal if the dog is to be sold or disposed of in any way. If Seller does not wish to acquire the dog, Seller will assist the Buyer in placing same.

That Buyer shall promptly notify Seller of any change in address made by Buyer.

That Buyer agrees to the pre-registration and registered name of this puppy to include the "Highwood" prefix.

That Buyer agrees to notify Seller of any titles completed as determined by the AKC.

That neither this dog, nor any progeny of this dog, shall be used for purposes of vivisection and they shall not be sold by or through any commercial or wholesale establishment, any chain store, catalog sales house, pet store or "puppy mill." This puppy or any progeny will not be offered as a prize in a raffle or auction.

At the time of sale this puppy showed no defects which would preclude him/her from the show ring according to the breed standard as specified by the Norwich Terrier Club and the American Kennel Club. (If sold as "show quality")

NO GUARANTEES OR WARRANTIES, EXPRESS OR IMPLIED, ARE GIVEN BY SELLER, AND ALL DOGS ARE SOLD AND DELIVERED IN AN "AS IS" CONDITION, EXCEPT AS EXPRESSLY AND SPECIFICALLY SET FORTH HEREIN.

It is agreed that this dog will not be used for breeding purposes prior to eighteen (18) months/or third season of age. Prior to breeding it must have documented clearances that this dog is brucellosis negative, and appropriate OFA (Orthopedic Foundation for Animals) examinations and eye screening by a board certified canine ophthalmologist (Cerf) have been conducted.

Seller warrants that she is the lawful owner of the dog, that the dog is free of all encumbrances, that she has the right to sell the same, and that she will warrant and defend the title to the dog from all lawful claims and demands.

That Buyer has read and understands the foregoing and agrees that all parts and portions thereof constitute a binding agreement. This contract constitutes the entire agreement of the parties hereto with respect to the sale hereinabove mentioned.
